1. **ANNOUNCEMENT**  
The Queensland Early Motorcycle Sports Club Incorporated, hereafter called the PROMOTER will conduct the QEMSC Interclub Race Meeting at Carnell Raceway, Stanthorpe, Qld on Saturday and Sunday 20th & 21st of **July 2013**. For classes of competition please see section 6 below.
2. **JURISDICTION**
  - 2.1 The abovementioned meeting has been authorised by Motorcycling Queensland who has issued the Motorcycling Australia Permit Number 41076 and is open to holders of current Motorcycling Australia Senior & **Junior** National & Senior National One Meeting Licences. **One meeting** licences will be sold on the day. **All participants ( Excluding Regularity entrants ) must be full financial members of QEMSC, Motorcycle Sportsmen, North Coast Road Racers or the Road Racing Association of Townsville.**
  - 2.2 The meeting will be held in accordance with the current Manual of Motorcycle Sport General Competition Rules (GCRs), these Supplementary Regulations, and any Final Instructions approved by Motorcycling Queensland.  
**BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.**
3. **ENTRIES**
  - 3.1 Entries open forthwith and close on **Sunday 7th July 2013**.
  - 3.2 In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by the promoter, if such retention is approved by Motorcycling Queensland.
  - 3.3 Only entries received on the official entry form that is accompanied by the correct fee will be accepted.
  - 3.4 **RETURN OF ENTRY FEES FOR ANY RIDER WITHDRAWING FROM THE MEETING WILL BE CONSIDERED ONLY IF NOTIFICATION IS GIVEN AT LEAST ONE WEEK PRIOR TO THE RACE DAY.**
  - 3.5 **ENTRY LISTS WILL BE LOADED ON OUR WEB SITE STARTING APPROX 4 WEEKS FROM RACE DAY**
  - 3.5 **ALL ENTRIES TO BE POSTED TO: Rex Dell, PO Box 3188, Southport MC, Q. 4215**
  - 3.6 All non members who are competing at this event for the first time will automatically be offered free membership of QEMSC for 2013.
4. **ENTRY FEE**
  - 4.1 An entry fee of \$150.00 will be charged for all senior solo and sidecar competitors. **Each entrant can compete in a maximum of 2 classes with either the same machine or a second machine.** Second machine entry please add \$15 for an extra timing transponder. No charge for spare machines in the same class. **One meeting licences will be available on the day at a cost of \$55.00.** Full payment MUST accompany the entry form. \$100.00 entry fee for the Junior GP125 class.  
**LATE ENTRIES MAY BE ACCEPTED SUBJECT TO A LATE PAYMENT FEE OF \$50 BUT MAY NOT BE INCLUDED IN THE SOUVENIR RACE PROGRAM.**
  - 4.2 Payment by cheque, money order or EFT. **ANY FEES FOR DISHONOURD CHEQUES WILL BE THE RESPONSIBILITY OF THE ENTRANT. DO NOT SEND CASH THROUGH THE MAIL.** Cheques and money orders are to be made payable to QEMSC. For those wishing to pay by EFT please make the payment to QEMSC BSB; 124001 Account number; 10419361. Please insert your name as the reference, print the transfer confirmation & post with your completed & signed entry form.

## 5. ENTRIES TO CONSTITUTE A CLASS

Classes of competition will be finalized approx 2 weeks before the event and are dependent on entries received for that class. Any decision to run a class, or to combine classes, will be at the discretion of the promoter, subject to the approval of the **RACE STEWARD**.

## 6. CLASSES OF COMPETITION

Class 1 # Historic sidecars – Period 3/4/5

Class 2 # Historic Period 2 – Pre 1946 solos up to 1300cc,

Class 3 # Historic Period 3 – Pre 1963 solos up to 1300cc

Class 4 # Historic Period 4 – 1963 to 1972 solos up to 500cc four stroke multis and 650 cc twins (track licence limitation)

Class 5 # Historic Period 5 – 1972 to 1982 solos up 350cc two stroke, 500cc four stroke multis, 650cc twins and 1000cc singles

Class 6 # Historic Period 6 -- 1983 to 1990 ( as per Period 5 )

**NOTE - All historic entries must have a current log book**

Class 7 #Modern Sidecars – Formula 1&2

Class 8 #Superlites & Motolites (as per GCR's & NCRR specifications)

Class 9 #Supermoto - As per Section 24 of 2013 Manual of Motorcycle Sport

Class 10 #Formula Stanthorpe ( non Historic machines over 200cc, up to 400 multis, 650cc twins & 1000cc singles)

Class 11 #Senior GP125 ( 125cc two stroke machines only )

Class 12 #Junior GP125 (14 and 15 year old junior riders with current GP125 accreditation ).

NOTE 1: Classes 9-12 will be run as one "Combined" event with individual points scoring for each class.

Class 13 #Regularity ( see Regularity info on QEMSC web site )

## 7. INSURANCE

7.1 MA's National Personal Accident Scheme provides basic cover for death and permanent disability only.

7.2 **IT IS STRONGLY RECOMMENDED THAT COMPETITORS GIVE CONSIDERATION TO TAKING OUT WEEKLY BENEFITS INSURANCE.**

## 8. MEDICAL SERVICES

An ambulance will be in attendance between 10.30am–5pm on Saturday and 9am–3pm Sunday.

9. **AWARDS: Medallions will be awarded for 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> for solo classes with at least 6 entries & sidecars with 4. First & second for less than 6 & first only for 3 or less. These will be handed out at the next QEMSC club meeting or if not in attendance will be posted out. NO AWARD OR PRIZES WILL BE HANDED OUT OVER THE WEEKEND. CLASS RESULTS WILL BE PUBLISHED ON THE CLUBS WEB SITE [www.qemsc.com.au](http://www.qemsc.com.au) AS SOON AS POSSIBLE AFTER THE EVENT**

11. **RACE FORMAT** Final race format will be based on entries received and will be decided after close of entries. The split of events between Saturday and Sunday (i.e. number of events each day) will be decided approx 2 weeks before the race meeting but will still be at the discretion of the **Clerk of the Course**.

## 12. MACHINES AND RIDERS

12.1 All historic machines entered must comply with the current GCRs for **Historic Road Race Competition**.

12.2 Multiple entry of the one machine in the same class of competition is not permitted.

12.3 Change of machine or rider is permitted up to 30 minutes prior to an event. Details of change must be submitted to the **Clerk of Course**.

12.4 Helmets are mandatory. All persons including officials using any bike, trike or quad at an event must be wearing a properly secured helmet at all times.

## 13. RIDING NUMBERS

13.1 Wherever possible, competitors will be allocated their preferred riding number.

For competitors in the "combined" event riders numbers will be allocated on a first entry basis.

No double up of race numbers will be allowed in this or any other event.

13.2 All number plates on all machines MUST comply with the GCRs.

## 14. GRID POSITIONS

Grid positions for Saturday will be determined by Saturday morning practice lap times,

Sunday grid positions will be determined by Sundays practice lap times.

**RIDERS WILL BE EXPECTED TO SELECT THE CORRECT GRID POSITION AND BE READY TO RACE WITHOUT DELAY.**

**NOTE: For Superlite/Motolite competitors grid positions will be progressive over the entire weekend,**

**ie Revised grid positions will be posted after every event for the following event.**

**A grid limit of 20 will apply to all events except for Superlite/Motolite which will be allowed 24 as per the 2013 track license.**

## 15. RIDERS BRIEFING

A riders briefing will be held prior to the commencement of racing on both days and **ALL Competitors MUST attend**. All riders attending the briefing shall sign the sign on sheet. Any riders failing to attend riders briefing or signing the attendance sheet may be excluded from the event. Riders Briefing is a NON Smoking Area.

## 16. DRUG AND/OR ALCOHOL TESTING

16.1 All competitors and officials are advised that as part of the MA drug education program, drug testing may take place at any competition in accordance with Australian Sports Commission policy as implemented by the Australian Sports Drug Agency.

16.2 If any doubts exist over banned substances it is recommended competitors telephone the Drugs in Sport Hotline 1800 020506. When drug testing takes place, the presentation of awards may be delayed at Motorcycling Queensland's discretion until the results of the tests are known.

## 17. CODE OF CONDUCT

All competitors, officials and parents are reminded of the Motorcycling Australia By-Law – CODE OF CONDUCT (as stipulated in the GCRs) which is a guide to appropriate behaviour at all motorcycle race meetings. This CODE OF CONDUCT applies to this meeting and will be enforced.

## 18. CIRCUIT DESCRIPTION

Carnell Raceway is approximately 1 km in length. Its surface is constructed of hot mix bitumen. Racing will be conducted in a clockwise direction.

ALL MACHINES MUST COMPLY WITH A 102dba STATIC TEST AND THE **2013** MANUAL OF MOTORCYCLE SPORT RULES 12.10.1.1. MACHINES MEASURED OVER 102dba MAY BE UNABLE TO COMPETE UNTIL THE NOISE IS REDUCED TO THE ACCEPTED LEVEL. **NOTE: THE CLUB WILL BE CONDUCTING NOISE TESTING ON ALL MACHINES AT THE DISCRETION OF THE CLERK OF THE COURSE.**

## 24. SPECIAL NOTES AND WARNINGS

### 24.1 NA

24.2 Protective Clothing shall be worn as per GCRs 15.4

24.3 Scrutineering will be located in pit lane.

### 24.4 HISTORIC LOG BOOKS ARE REQUIRED FOR ALL HISTORIC MACHINES.

(Pre 1990 machines without log books that are within the track limitations may compete in Formula Stanthorpe).

24.5 Protests will be lodged as per **2013** Manual of Motorcycle Sport Rule 5.1.

24.6 FUEL: is not available at the track.

24.7 ALCOHOL IS NOT PERMITTED WITHIN THE PIT AREA DURING COMPETITION HOURS.

RIDERS CONTRAVENING THIS RULE WILL BE EXCLUDED FROM THE DAY'S EVENTS.

24.8 CHILDREN ON WHEELED DEVICES OF ANY KIND ARE NOT PERMITTED IN THE PIT AREA. These devices will be confiscated and returned at close of racing. CHILDREN UNDER 16 YEARS OF AGE ARE NOT PERMITTED IN THE PIT LANE.

### 24.9 NO DOGS ARE ALLOWED WITHIN THE CIRCUIT GROUNDS AT ANY TIME.

24.10 The promoter recommends that all competitors have a suitable fire extinguisher.

24.11 Any last minute changes to the classes of competition will be announced at riders briefing and are dependant on entries received for each class.

24.13 ALL NOVICE OR FIRST TIME RACERS ARE REQUIRED TO BRING A WHITE T-SHIRT TO WEAR OVER THEIR LEATHERS TO MAKE IT EASIER FOR FASTER RIDERS TO IDENTIFY YOU.

24.14 **Entry acceptance letters will NOT be sent out prior to this event. DO NOT SEND A SELF ADDRESSED ENVELOPE WITH YOUR ENTRY. Nominations will be posted on the website [www.gemsc.com.au](http://www.gemsc.com.au) in early July or they can be checked by contacting race organizer David Vincent [webmaster@gemsc.com.au](mailto:webmaster@gemsc.com.au) or 0412 717929**

24.15 Entrants with duplicate numbers in the same event will be informed by phone or email prior to the event if they need to change their number (first entry received will be given their preferred number).

24.16 Camping at the track will be permitted on Friday ( from 4pm ) & Saturday nights.

24.17 **The canteen will be open for lunch on Saturday and breakfast and lunch on Sunday.**

24.18 Carnell Raceway address is Rifle Range Rd, Stanthorpe Qld.

## CONTRACT TO PARTICIPATE IN THE QEMSC INTERCLUB MEETING

**WARNING! THIS IS AN IMPORTANT DOCUMENT WHICH AFFECTS YOUR LEGAL RIGHTS AND OBLIGATIONS, PLEASE READ IT CAREFULLY AND DO NOT SIGN IT UNLESS YOU ARE SATISFIED YOU UNDERSTAND IT.**

1. I THE UNDERSIGNED (see below): [Insert Name]

"Gross negligence" is defined in the Fair Trading (Recreational Services) Regulations 2004.

For the purposes of the clause 3, "the Supplier" shall mean and include the Indemnitees.

### 5. INDEMNITY AND RELEASE GIVEN TO ORGANISERS

IN CONSIDERATION of the acceptance of me as a participant in the Meeting:

a) I AGREE TO INDEMNIFY AND KEEP INDEMNIFIED to the full extent permitted by law the Indemnitees and each of them in the following manner:

- i) that I participate in the meeting at my sole risk and responsibility;
- ii) that I accept the Venue as it stands with all or any defects hidden or exposed;
- iii) that I indemnify and hold harmless the Indemnitees, their respective servants, agents, officials and competitors against any actions, costs, losses or claims which may be made by me or on my behalf for or in respect of or arising out of my death or any injury loss or damage caused to me or my equipment whether caused by negligence, breach of contract or in any other manner whatsoever.

c) The release and indemnity provided by me in this declaration is in addition to, and will not in any way limit the application of, the conditions of sale attaching to tickets, conditions of entry, conditions of credentials or any other applicable terms or conditions in respect of the Event.

d) A term of this release and indemnity will not apply where the term contravenes the law of the relevant jurisdiction under which any legal action is legitimately taken however such terms are severable and do not invalidate the remaining terms.

### 6. MEDICAL

I declare that I am and must continue to be medically and physically fit and able to participate in the Meeting. I will immediately notify MA in writing via my SCB of any change to my fitness and ability to participate. I understand and accept the Indemnitees will continue to rely upon this declaration as evidence of my fitness and ability to participate.

I acknowledge and agree that if required, the Indemnitees (or any of them) may arrange medical or hospital treatment (including ambulance transportation) for me. I authorise such actions being taken by the Indemnitees and agree to meet all costs associated with such action. I understand it is compulsory for me to have ambulance insurance in some form and I accept responsibility for the cost of ambulance transportation, ambulance cover and further agree to maintain ambulance cover during the term of my license / membership.

### 7. PRIVACY

I hereby consent to the collection of my personal information by the Promoter/Event Organiser, MA and the SCB in connection with my involvement at the Event and the use and disclosure of my personal information by Event Organiser, and MA to other agencies and officials associated with the Event for the purposes of conducting and managing the Event. ### 8. PERSONAL HEALTH INFORMATION
